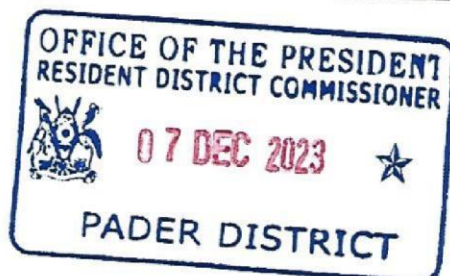
RE: REPORT ON THE IMPLEMENTATION OF THE EXECUTIVE ORDER NO. 3 OF 2023 (EVICTION) OF NON COMPLIANCE BALALO FROM PADER DISTRICT AS OF 07TH DECEMBER, 2023.

01. BRIEF FACTS

- The Executive Order was extended from 3rd November, 2023 to 24th November, 2023, prior to that this Office met all the Balalos on the 21st November, 2023 and alerted those who had not complied to do so or face the Eviction.
- The Eviction exercise Code named "Operation Harmony – Cattle Economy" was implemented by District Security Committee on 6th December, 2023 with the UPDF on the lead followed by the Uganda Police Force and Intelligence.
- The Political Head of the District LCV Chairman Rtd Col. Fearless Obwoya Oyat participated fully in the Eviction together with District Technical Team (DVO) and his Staff at the Sub County as well as the Sub County Security Committee (LCIII Chairpersons and GISOs).



Awio Patrick Ogwang a Lango from Lira City	Biwang Village, Tyer Parish, Pader Sub County	Bought 10 acres of Land (Inherited from Late Father)	154 herds of cattle	<ul style="list-style-type: none"> Land very small 10 acres keeping 154 cows and not fenced. Stray animals destroyed a family garden but compensated No permanent water source At first poor relationship with the community but later on improved. Eviction successful

- Total No. of Animals so far evicted from Pader District as of 07/12/2023 = 261
Total No. of Animals awaiting to be transported out of the District as of 07/12/2023 = 47
Grand Total = 308
- The operation is still ongoing in the District for the non-compliant Balalo.
