RE: ACCOUNTABILITY REPORT ON THE DISBURSEMENT OF PARTY FUNDS FOR WOMEN COUNCIL AND LC I & LC II ELECTION ACTIVITIES IN AMOLATAR DISTRICT

I, Pule Boniface, the NRM Administrative Secretary for Amolatar District, respectfully submit this report to explain my role in the receipt, management, and disbursement of funds allocated by the National Resistance Movement (NRM) Secretariat to facilitate activities relating to the Women Council Elections and LC I & LC II elections in Amolatar District.

The NRM Secretariat disbursed a total of UGX 165,000,000 to Amolatar District to facilitate the implementation of the approved election activities. In accordance with the guidelines issued by the Party Secretariat, the funds were allocated to support village barazas, mobilization activities, facilitation of NRM Women Council flag bearers, LC I flag bearers, security operations, and other approved election-related activities.

On 21st July, together with the District Executive Committee (DEC), we conducted the official disbursement of these funds to all the 16 sub-counties of Amolatar District. During this exercise, every NRM Sub-county Chairperson received the funds allocated to his or her respective sub-county and signed the official payment vouchers acknowledging receipt in accordance with the approved guidelines.

As the NRM Administrative Secretary, my responsibility was purely administrative. My duties included preparing the payment vouchers, coordinating the accountability process, ensuring that every intended beneficiary signed for the funds received, and confirming that the funds were delivered promptly to the respective Sub-county Chairpersons. The actual cash disbursement was undertaken by the District Treasurer, while I prepared the documentation and supervised the accountability process.

The objective of the disbursement was to enable each Sub-county Chairperson to mobilize villages and parishes, organize village barazas, and facilitate NRM Women Council flag bearers and LC I flag bearers in preparation for the elections.

The disbursement exercise was conducted transparently and in the presence of the District Executive Committee. In addition, the facilitation earmarked for district security was acknowledged and signed for by the Resident District Commissioner (RDC), Amolatar, in his capacity as the head of district security. Members of the District Executive Committee also signed for their approved facilitation, while all NRM Sub-county Chairpersons signed for the funds allocated to their respective sub-counties.

Following the completion of the exercise, I ensured that all funds had been handed over to the intended beneficiaries as provided for under the approved budget. To the best of my knowledge, there were no surplus or unaccounted-for funds remaining after the disbursement.

It was therefore with surprise that I later learnt of the arrest of the NRM District Chairperson together with the District Treasurer over allegations of diversion of party funds and attempted bribery involving the RDC.

Based on my direct involvement in the disbursement process, I wish to state that the entire allocation received from the Party Secretariat had already been distributed to the approved beneficiaries in accordance with the approved budget and guidelines. Consequently, I am not aware of any additional funds that remained available to finance any activity outside the approved disbursement.

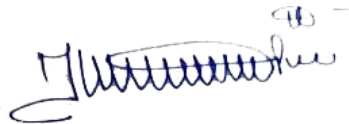
It is therefore upon the District Chairperson and the District Treasurer to explain the source of the money allegedly involved in the incident that led to their arrest, as those matters fall outside my mandate and knowledge.

I respectfully wish to disassociate myself from any alleged wrongdoing involving the District Chairperson and the District Treasurer. My role was strictly limited to the administrative coordination of the disbursement process, preparation of payment vouchers, ensuring that all beneficiaries acknowledged receipt by signing, and confirming that the funds reached the intended recipients in a timely manner.

For purposes of transparency and accountability, I have attached copies of the duly signed payment vouchers showing all beneficiaries who received the funds.
